NOTE BY THE SECRETARIAT

1. The revision process for the International Standard Industrial Classification of All Economic Activities (ISIC) and the Central Product Classification (CPC), both with a target date of 2007, is being conducted in subsequent rounds of discussion by the United Nations Statistics Division and related bodies.
2. As part of the OECD's contribution, a proposal for the revision of Section 18: Health and Social Services was submitted early this year. The aim of this proposal was to give higher status to health in the hierarchy of the ISIC ("Division" level instead of "Group" level) and to improve the correspondence between the International Classification for Health Accounts (ICHA) and the health component of the above economic classifications. Part of the OECD's proposals was endorsed and included in the draft version of ISIC Rev 4 that is currently under a world-wide discussion with the deadline of 10 October, 2004.
3. The main purpose of this paper is to inform the participants about the current status of health in ISIC Rev 4 and present the proposals that the Secretariat intends to make.
4. The Secretariat invites participating experts to:
 - COMMENT on the proposal by the Secretariat concerning the draft version of ISIC Rev.4; and
 - COMMENT on the proposal by the Secretariat concerning the revision of CPC.

Introduction

5. The Manual *A System of Health Accounts* provides the International Classification for Health Accounts (ICHA) that has been designed to reflect the characteristics of the health sector. General economic classifications obviously include health from the point of view of the overall economy. Furthermore, at this moment, health is given lower status in ISIC and CPC than it plays in national economies¹. The harmonisation between the ICHA and the health component of the general economic classifications will be a longer process. The contribution by the Secretariat to the current revision of ISIC and CPC can be regarded as an important step in this process.

Current status of health in ISIC Rev 4

6. The OECD Statistics Directorate (STD) put forward our proposal, among other proposals by the OECD, for the revision of health in ISIC (Annex 1) at the meeting of the UN TSG (Technical Subgroup of the Expert Group on International Economic and Social Classification)². At the UN TSG meeting, the OECD proposal concerning health was supported strongly by the representative of the United States, but members from Europe and Australia raised various problems of splitting in an internationally comparable way long-term care and social work activities with accommodation. As TSG wanted only uncontroversial internationally comparable splits at the two digit level, the US proposed a compromise which was agreed for the worldwide consultation on ISIC Rev 4 draft (Annex 2).

7. The proposed structure is as follows³:

Section Q - Human health and social work

New Division 77 – Human Health Activities consisting of:

771 – Hospital activities

772 – Medical and dental practice activities

779– Other human health activities

New Division 78 – Residential Care Services, consisting of:

781 Nursing care facilities

782 Residential mental retardation, mental health and substance abuse facilities

783 Community care facilities for the elderly

789 Social work activities with accommodation

New Division 79 – Social work activities without accommodation, consisting of:

790 – Social work activities without accommodation

¹ Both in the currently used ISIC Rev 3.1 and CPC 1.1, health is recognised at a group (three-digit) level that is below the level for which international comparison is aimed. At this moment the relevant level of international comparability is: Division 85 Health and Social Work in ISIC Rev.3.1 (within Section N Health and Social Work), and Division 93 Health and social services in CPC 1.1 (within Section 9 Community, social and personal services).

² Before submitting our proposal to OECD STD, it was sent to the Network of Health Accounts Experts and it received positive responses last November.

³ It was agreed by the UN TSG that the classes above would be presented as 3-digit groups (each group would be identical to the sole class under it), allowing for national adaptation at the 4-digit level. It was agreed to move Veterinary Services to Professional, scientific and technical services.

8. This version raises health services to a proper two digit status. At the same time, however, Division 78 Residential Care Services contains health and social services in a way that makes the mapping between ISIC and ICHA-HP (Classification of Health Care Providers) impossible at the division (two-digit) level. It is also not possible to distinguish long-term care services (health and social services together) at division level. The growing importance of health and social services for the elderly would justify changes in statistics in this respect.

Proposal to modify the division structure of Section Q: Human health and social work

9. The main purpose of this proposal is to provide better possibilities to create a correspondence between ISIC and ICHA-HP at the division (two-digit) level, and to make it possible to recognize long-term care in an internationally comparable way. From this point of view, the most important problem is that Group 789: *Social work activities with accommodation* covers services for all social groups (the aged, handicapped, homeless, and children) together. Therefore our proposal intends to distinguish between services for the elderly and handicapped, and services for other social groups. The Secretariat plans to propose two versions.

10. Version (A) would consist of the following 5 divisions within Section Q (instead of 3 listed above)

- Division 77 – Human Health Activities
- Division 78 – Residential Care Services for the aged and disabled
- Division 79 – Other Residential Care Services
- Division 80 – Social work activities without accommodation for the aged and disabled
- Division 81 – Other social work activities without accommodation

This would allow for the production of internationally comparable data for health and long-term care services (Division 77, 78 and 80); and health services without LTC (Division 77).

11. With the same aim, Version (B) distinguishes between services for the aged and handicapped and services for other social groups at Group level. The following is proposed:

- To replace 789 Social work activities with accommodation by:
 - 784 Social work activities with accommodation for the aged and disabled
 - 789 Social work activities with accommodation other than 78
- To replace 790 Social work activities without accommodation by:
 - 791 Social work activities without accommodation for the aged and disabled
 - 792 Social work activities without accommodation other than 791

Proposal for the CPC

12. The current proposal for health in ISIC Rev 4 requires the modification of the Secretariat's original proposal for health in CPC. The modified proposal has three main aims:

- To keep the correspondence between ISIC and CPC.
- To provide a better possibility to create a correspondence between ISIC and ICHA-HC (Functional Classification of Health Care)
- To make possible the recognition of long-term care at an internationally comparable level

13. Annex 3 presents the modified proposal.

ANNEX 1: ORIGINAL PROPOSAL BY THE SECRETARIAT (2003 DECEMBER)**Proposal for modification of the hierarchy and breakdown for Human health activities in ISIC and CPC**

14. The dynamic growth, structural changes and increasing complexity in the health care sector, which is now the largest service industry in many countries, call for changes in the current structure of Section 18: Health and Social Services. These are supported by progress in statistical systems reporting on the health sector in recent years.

15. The OECD Secretariat published the manual, A System of Health Accounts (SHA) in 2000. The System of Health Accounts proposes an International Classification for Health Accounts (SHA-ICHA) that covers three dimensions: functions of health care, industries of health care providers, and sources of finance. The provider (industry) component (ICHA-HP) is relevant, not only for health accounting, but also for integrating non-monetary health care statistics with health accounts (see Annex 1. on the measurement of human resources in health care of the SHA manual). The International Classification for Health Accounts (ICHA) is now used as a quasi-standard by health accountants and health statisticians in many non-OECD countries as well. The status of quasi-standard has recently been acknowledged in the WHO/World Bank/USAID publication in 2003 of "Guide to producing national health accounts with special applications for low-income and middle-income countries".

16. The ICHA-HP follows very closely a short-version of the latest version of the NAIC (from which it borrows many labels, and part of the wording of many definitions), but with some modifications suggested from European countries and Eurostat, as well as from several Asian and Asian Pacific countries. For these reasons, it would be advisable to build on what has been achieved so far with the current fine-structure and detailed definitions.

17. Taking all these points into account, it would be desirable to take ICHA-HP into consideration when the new Section 18 is designed.

18. For a revision of the CPC classification, the functional classification of the ICHA (ICHA-HC) offers guidance. (The Health Data Team plans to further complete this draft proposal concerning Human health services in CPC next year.)

**ANNEX 2: SECTION Q: HUMAN HEALTH AND SOCIAL WORK IN ISIC COMPLETE
STRUCTURE DRAFT FOR DISCUSSION (MAY 2004)**

Q Human health and social work

77 Human health activities

This division comprises short- or long-term hospitals, general or specialty medical, surgical, psychiatric and substance abuse hospitals, sanatoria, preventoria, medical nursing homes, asylums, mental hospital institutions, rehabilitation centres, leprosaria and other human health institutions which have accommodation facilities and which engage in providing diagnostic and medical treatment to inpatients with any of a wide variety of medical conditions. It also includes medical consultation and treatment in the field of general and specialized medicine by general practitioners and medical specialists and surgeons. It includes dental practice activities of a general or specialized nature and orthodontic activities. Additionally, this division includes activities for human health not performed by hospitals or by practising medical doctors but by paramedical practitioners legally recognized to treat patients.

771 Hospital activities

See class 7710.

7710 Hospital activities

This class includes:

- short- or long-term hospital activities of general and specialized hospitals, sanatoriums, preventoria, medical nursing homes, asylums, mental hospital institutions, rehabilitation centres, leprosariums and other health institutions that have accommodation facilities, including military-base and prison hospitals:
 - medical and surgical technical care activities such as diagnosis, treatment, operations, analyses, emergency activities etc.

The activities are chiefly directed to inpatients, are carried out under the direct supervision of medical doctors and comprise:

- services of medical and paramedical staff
- services of laboratory and technical facilities, including radiologic and anaesthesiologic services
- emergency room services
- provision of operating room services, pharmacy services, food and other hospital services
- services of family planning centres providing medical treatment such as sterilization and termination of pregnancy, with accommodation.

This class also includes the provision of outpatient services and home health care services.

This class excludes:

- laboratory testing and inspection of all types of materials and products, see 6620
- health activities for military personnel in the field, see 8722
- private consultants' services to inpatients, see 7720
- dental practice activities of a general or specialized nature, e.g. dentistry, endodontic and pediatric dentistry; oral pathology, orthodontic activities, see 7720
- ambulance activities, see 7790
- veterinary activities, see 7000

772 Medical and dental practice activities

See class 7720.

7720 Medical and dental practice activities

This class includes:

- medical consultation and treatment in the field of general and specialized medicine by general practitioners and medical specialists and surgeons
- dental practice activities of a general or specialized nature, e.g. dentistry, endodontic and pediatric dentistry; oral pathology
- orthodontic activities
- family planning centres providing medical treatment such as sterilization and termination of pregnancy, without accommodation

These activities can be carried out in private practice, group practices and in hospital outpatient clinics, and in clinics such as those attached to firms, schools, homes for the aged, labour organizations and fraternal organizations, as well as in patients' homes.

This class also includes:

- dental activities in operating rooms
- private consultants' services to inpatients

This class excludes:

- production of artificial teeth, denture and prosthetic appliances by dental laboratories, see 3250
- inpatient hospital activities, see 7710
- paramedical activities such as those of midwives, nurses and physiotherapists, see 7790

779 Other human health activities

See class 7790.

7790 Other human health activities

This class includes:

- activities for human health not performed by hospitals or by medical doctors or dentists:
 - activities of nurses, midwives, physiotherapists or other paramedical practitioners in the field of optometry, hydrotherapy, medical massage, occupational therapy, speech therapy, chiropody, homeopathy, chiropractic, acupuncture etc.

These activities may be carried out in health clinics such as those attached to firms, schools, homes for the aged, labour organizations and fraternal organizations and in residential health facilities other than hospitals, as well as in own consulting rooms, patients' homes or elsewhere.

This class also includes:

- activities of dental paramedical personnel such as dental therapists, school dental nurses and dental hygienists, who may work remote from, but are periodically supervised by, the dentist
- activities of medical laboratories such as:
 - X-ray laboratories and other diagnostic imaging centres
 - blood analysis laboratories
- activities of blood banks, sperm banks, transplant organ banks etc.
- ambulance transport of patients by any mode of transport including airplanes. These services are often provided during a medical emergency.
- residential health facilities, except hotels

This class excludes:

- production of artificial teeth, denture and prosthetic appliances by dental laboratories, see 3250
- testing activities in the field of food hygiene, see 6620
- hospital activities, see 7710
- medical and dental practice activities, see 7720
- transfer of patients, with neither equipment for lifesaving nor medical personnel, see divisions 45, 46, 47

78 Residential care services

This division comprises the provision of residential care combined with either nursing, supervisory or other types of care as required by the residents. Facilities are a significant part of the production process and the care provided is a mix of health and social services with the health services being largely some level of nursing services.

781 Nursing care facilities

See class 7810.

7810 Nursing care facilities

This class includes:

- homes for the elderly with nursing care
- convalescent homes

ISIC Rev.4 draft – May 2004

- rest homes with nursing care
- nursing care facilities
- residential mental retardation facilities
- nursing homes
- continuing care retirement communities

This class excludes:

- social work activities with accommodation, such as orphanages, children's boarding homes and hostels, temporary homeless shelters, see 7890
- in-home services provided by health care professionals, see division 77
- homes for the elderly with minimal nursing care, see 7830

782 Residential mental retardation, mental health and substance abuse facilities

See class 7820.

7820 Residential mental retardation, mental health and substance abuse facilities

This class comprises the provision of residential care (but not licensed hospital care) to people with mental retardation, mental illness, or substance abuse problems. Facilities provide room, board, protective supervision and counselling and some health care. It also comprises provision of residential care and treatment for patients with mental health and substance abuse illnesses.

This class includes:

- alcoholism or drug addiction
- psychiatric convalescent homes
- residential group homes for the emotionally disturbed
- mental retardation facilities
- mental health halfway houses

This class excludes:

- social work activities with accommodation, such as temporary homeless shelters, see 7890

783 Community care facilities for the elderly

See class 7830.

7830 Community care facilities for the elderly

This class comprises the provision of residential and personal care services for (1) the elderly and other persons who are unable to fully care for themselves and/or (2) the elderly and other persons who do not desire to live independently. The care typically includes room, board, supervision, and assistance in daily living, such as housekeeping services. In some instances these units provide

skilled nursing care for residents in separate on-site facilities.

This class includes:

- assisted-living facilities
- continuing care retirement communities
- homes for the elderly with minimal nursing care
- rest homes without nursing care

This class excludes:

- homes for the elderly with nursing care, see 7810
- social work activities with accommodation where medical treatment or accommodation are not important elements, see 7890

789 Social work activities with accommodation

See class 7890.

7890 Social work activities with accommodation

This class includes:

- activities provided on a round-the-clock basis directed to provide social assistance to children, the aged and special categories of persons with some limits on ability for self-care, but where medical treatment or education are not important elements:
 - orphanages
 - children's boarding homes and hostels
 - homes for the aged
 - homes for the physically or mentally handicapped, including the blind, deaf and dumb
 - temporary homeless shelters
 - institutions that take care of unmarried mothers and their children

The activities may be carried out by government offices or private organizations.

This class excludes:

- funding and administration of compulsory social security programmes, see 8730
- adoption activities, see 7900
- short-term shelter activities for disaster victims, see 7900
- nursing care facilities, see 7810

79 Social work activities without accommodation

See class 7900.

790 Social work activities without accommodation

See class 7900.

7900 Social work activities without accommodation

This class includes:

- social, counselling, welfare, refugee, referral and similar services which are delivered to individuals and families in their homes or elsewhere and carried out by government offices or by private organizations, disaster relief organizations and national or local self-help organizations and by specialists providing counselling services:
 - welfare and guidance activities for children and adolescents
 - adoption activities, activities for the prevention of cruelty to children and others
 - visiting of the aged and sick
 - household budget counselling, marriage and family guidance, credit and debt counselling services
 - community and neighbourhood activities
 - activities for disaster victims, refugees, immigrants etc., including temporary or extended shelter for them
 - vocational rehabilitation and habilitation activities for handicapped or unemployed persons provided that the education component is limited
 - eligibility determination in connection with welfare aid, rent supplements or food stamps
 - child day-care activities, including day-care activities for handicapped children
 - day-care activities for handicapped adults
 - day facilities for the homeless and other socially weak groups
 - charitable activities like fund-raising or other supporting activities aimed at social work

This class excludes:

- funding and administration of compulsory social security programmes, see 8730
- activities similar to those described in this class, but including accommodation, see 7890
